# ADMISSIONS AT A GLANCE

## Admissions Requirements



18 years of age or older

If under 18, you must provide proof that you have completed high school (high school diploma, CHSPE, GED, HiSET, etc.)



Students currently attending high school can also attend with permission from their parents/counselor/principal as a H.S. Concurrent Enrollment student



Individuals in the US on an active tourist visa (B1 or B2) are not able to enroll

## Application & Enrollment Periods

- SMC has 4 semesters annually – Winter, Spring, Summer & Fall.
  - Spring & Fall are full length semesters, Winter & Summer are short term sessions
- We link the Winter & Spring as well as the Summer & Fall semesters for application and enrollment purposes, which means you can apply and enroll for multiple terms with just one application!

# HOW TO APPLY

## SMC uses CCCApply

- A statewide application system used by all California Community Colleges

## Application is FREE

## Apply at [www.smc.edu/Apply](http://www.smc.edu/Apply)

- The very first step of the application process is to create an account with CCCApply.
- If you have previously applied for, or attended, another California Community College you may already have an account with CCCApply.

# CCC APPLY – BEFORE YOU BEGIN


- The CCCApply application will ask for your personal information such as contact info, your educational history, the amount of time you have lived in California, and your citizenship status.
  - It is best to gather documents such as passports, visas, and school transcripts before starting the application to ensure you have all you need.
- The application does save your progress as you complete each section
  - If you reach a point where you do not have the information you need to proceed, you can return to complete your in-progress application later.

# NAVIGATING THE APPLICATION - SSN

- Social Security, or Taxpayer Identification numbers are optional!

## Social Security Number

The Social Security Number (SSN) or Taxpayer Identification Number (TIN/iTIN) is used by the college as a means of matching student records, facilitating federal financial aid, and reporting tax-related information to the Internal Revenue System (IRS). However, it is not required for admission.

Why am I being asked for my social security number? 

### **Do you have a social security number or taxpayer identification number?**

- Yes, I have a social security number or taxpayer identification number.
- No, I do not have a social security number or taxpayer identification number, or I decline to provide one at this time.

- Select "Other" on the "Citizenship & Immigration" question. Then, click the "No Documents" checkbox.



# NAVIGATING THE APPLICATION – RESIDENCY



The application will classify you as either a California Resident, or a California Non-Resident.

This is based on a variety of factors such as the time you have lived in California, your citizenship status, your age & parental status.



**Note: As an undocumented student, you will be admitted as a California Non-Resident, however that does not automatically mean you will be required to pay non-resident fees.**



California has a law that allows **qualified Non-Residents to be exempted from paying non-resident tuition**, provided they qualify for an AB 540 tuition exemption (based on school attendance and HS graduation).

# ADMISSION & ONBOARDING

## Once you submit your application

- You will receive an Application Confirmation Number
  - Take note of this number in case you need to follow up.
- Most applications are received and processed within an hour of submission, however there can be delays in that process.
- There are various validations within the CCCApply system, as well as at SMC, that are intended to filter out fraudulent and spam applications.
- If you do not receive an email from SMC with your Student ID Number within 24-hours, contact SMC Admissions & Records with your Application Confirmation Number at [admissions@smc.edu](mailto:admissions@smc.edu).

# SETTING UP YOUR STUDENT ACCOUNT

## Once you have been admitted

- You will receive some emails with your next steps, so you may set up your SMC account:
  - Verify Your Email – Within your first admissions email there is a link embedded to verify your personal email, click that to continue the process.
- Set-Up Your Password – Once you have verified your email you will receive a follow up message with a link to set up your account. This will require to create a personalized password, security questions, and designate a preferred recovery method in case you ever forget your password.
- You will receive another email with "Your SMC Tasks": any outstanding issues, placement, orientation, counseling, financial aid, enrollment.

# SUBMITTING THE AB-540

## Once you have been admitted

- ...and have set up your Student Account, submit your AB 540 affidavit.
- **If you qualify, you will pay in-state fees and qualify for California-based financial aid options. To qualify, we need to see that you have attended at least 3 years of school in California and graduated from a California based school (HS Diploma, AA, IGETC, or CSU GE)**
- Submit the AB 540 form online at [www.smc.edu/Forms](http://www.smc.edu/Forms)
- you will be required to sign-in to your SMC account so be sure to set everything up first.

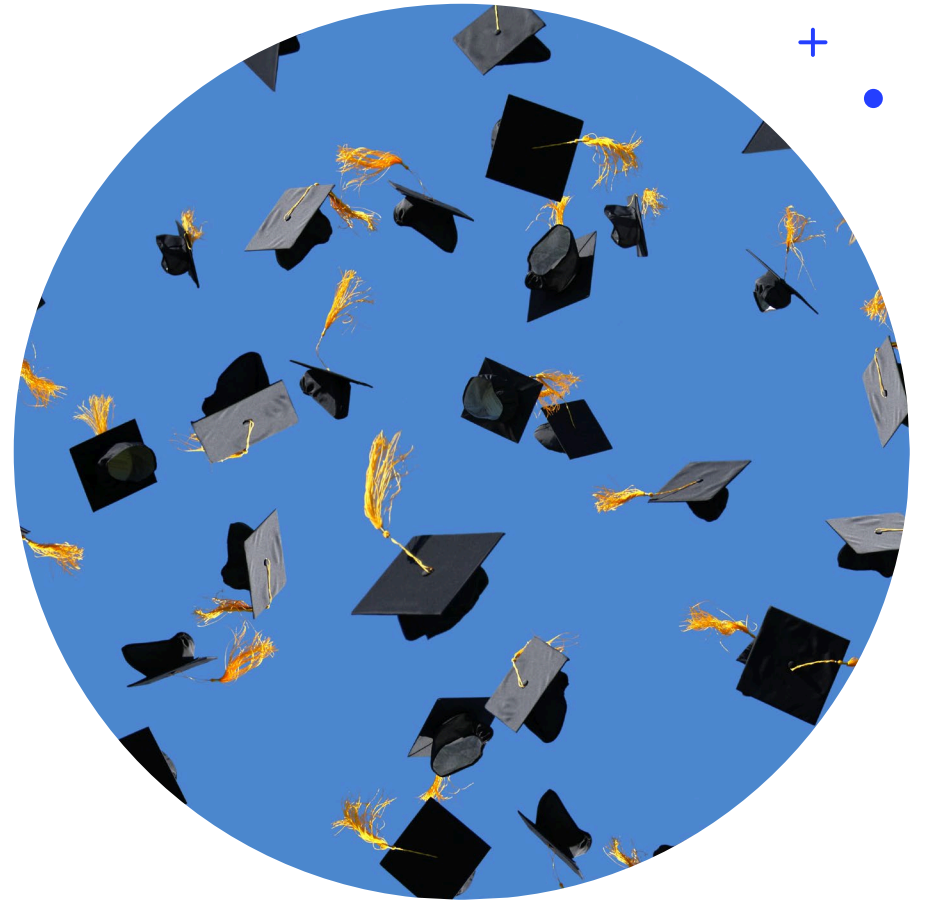

# CA DREAM ACT APPLICATION THE CHALLENGES

- More than half of California's undocumented students in postsecondary education (53%) do not fill out a California Dream Act Application (CADAA).
- Among undocumented students in postsecondary education who do fill out a CADAA, only 30% ultimately enroll and receive state financial aid.
- Only 14% of California's estimated undocumented student population in postsecondary education receives financial aid to support their higher education goals.

# About the California Dream Act Application

The California Dream Act Application allows students interested in attending eligible California Colleges, Universities and Career Education/Vocational Programs to apply for state and campus financial aid.

The State Financial Aid programs available at SMC are CA College Promise Grant (CCPG), Cal Grant, Student Success Completion Grant (SSCG), and Chafee Grant.

# CA State Aid at SMC: CA College Promise Grant (CCPG)

The CCPG, waives the enrollment fees and tuition for eligible California residents attending a California Community College. The CCPG Fee Waiver will waive your per-unit enrollment fee for the entire academic year if you apply and qualify.

Millions of dollars of financial aid go unused every year because students don't think they will qualify, which in many cases isn't true. The California College Promise Grant (CCPG) waives community college enrollment fees if you're eligible.

Fill out the **FAFSA** or the **California Dream Act** application for additional financial aid to help with other costs of attendance (books, food, rent, etc.).

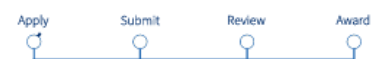

# CA STATE AID AT SMC: CAL GRANT



PRESENTATION TITLE

- Students receive Cal Grants for a maximum of 4 years/400% except for mandatory 5-year programs or teacher credential programs
- Cal Grants are only for undergraduate programs
- Must be used at a Cal Grant eligible college in California
- Cal Grants can be put “on hold” for up to 2 years
- Cal Grant C is for an occupational or technical program and does not require a GPA.

# CA STATE AID AT SMC: CAL GRANT B

- Cal Grant B requirement is 2.0 GPA
- Recent high school graduates who have not earned 16 units of degree applicable coursework at the college level need to have their GPA verified by their high school.
- If you attended SMC in the last 10 years, and completed 16 or more-degree applicable units, SMC will submit your GPA to CA Student Aid Commission

# CA STATE AID AT SMC: STUDENT SUCCESS COMPLETION GRANT (SSCG)



PRESENTATION TITLE

- The SSCG is a supplemental grant with the purpose of providing students with additional financial aid to help offset the total cost of community college and to encourage full-time attendance and successful on-time completion. Students must be receiving a Cal Grant B or C and is enrolled at least full-time per term.

# CA STATE AID AT SMC: STUDENT SUCCESS COMPLETION GRANT (SSCG),



- The Chaffe Grant provides financial assistance to former and current foster youth for college and vocational training. Awards range up to \$5,000 per academic year.
- Be a current or former foster youth, not have reached your 22<sup>nd</sup> birthday as of July 1 of the award year and have financial need.
- Must Submit a CA Dream Act Application and a California Chafee Grant Program Application.

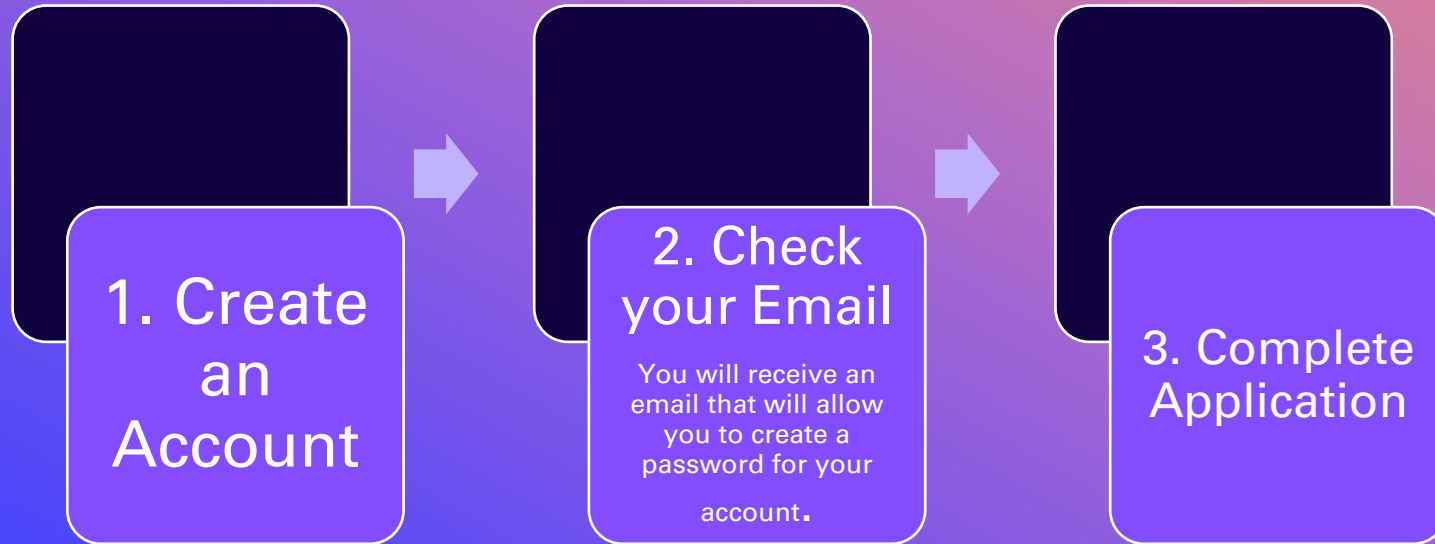

# Dependency Questions:

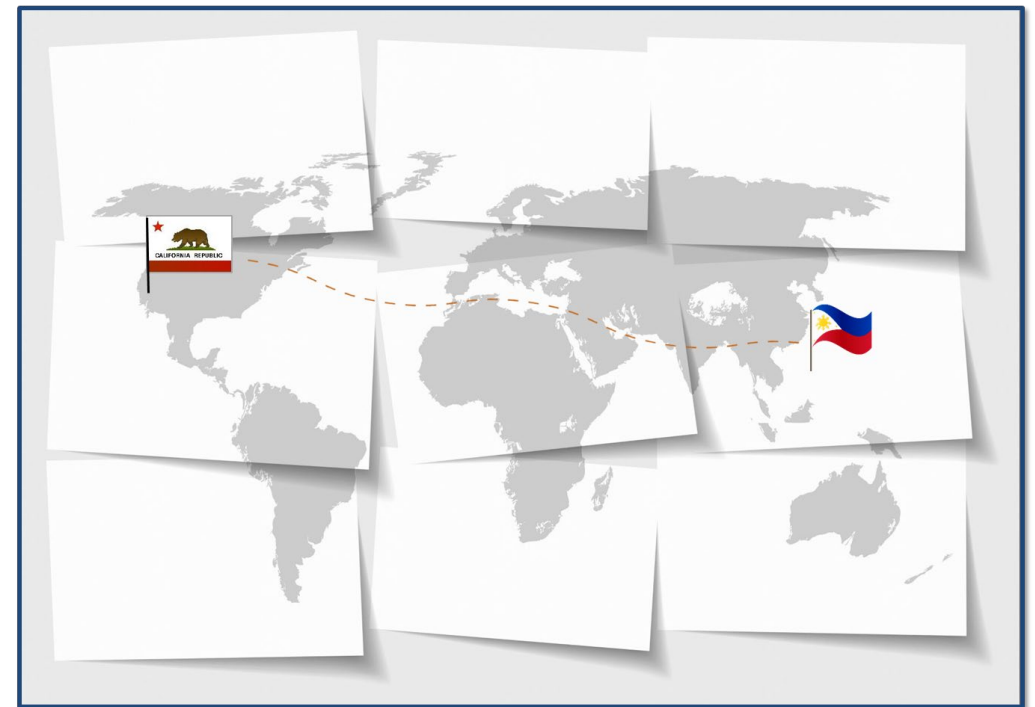
This section is to determine if you will need to provide parental information. Here are the following questions:

- Were you born before January 1, 2000?
- As of today, are you married?
- At the beginning of the 2023-2024 school year, will you be working on a master's or doctorate program (such as an MA, MBA, MD, JD, PhD, EdD, graduate certificate, etc.)?
- Are you currently serving on active duty in the U.S. Armed Forces for purposes other than training?
- Are you a veteran of the U.S. Armed Forces?
- Do you now have or will you have children who will receive more than half of their support from you between July 1, 2023 and June 30, 2024?
- Do you have dependents (other than your children or spouse) who live with you and who receive more than half of their support from you, now and through June 30, 2024
- At any time since you turned age 13, were both your parents deceased, were you in foster care or were you a dependent or ward of the court?
- As determined by a court in your state of legal residence, are you or were you an emancipated minor?
- Does someone other than your parent or stepparent have legal guardianship of you, as determined by a court in your state of legal residence?
- At any time on or after July 1, 2022, did your high school or school district homeless liaison determine that you were an unaccompanied youth who was homeless?
- At any time on or after July 1, 2022, did the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and Urban Development determine that you were an unaccompanied youth who was homeless?
- At any time on or after July 1, 2022, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless?

If you answered “Yes” to any of these questions you will be considered independent. If you answered “No”, initially you will be considered dependent and asked to submit parent information.

# What if a Student's Parent(s) Live in Another Country?

- Even if a parent/contributor lives in another country, they are required to provide their income and assets
- When that is not possible because there is no contact with the parents, students should complete the application as much as they can and then contact their college's financial aid office as soon as possible
- The college financial aid office will evaluate the situation and inform the student if they can override the need for parent information
