# Nursing Career/Major Exploration: Important Qualities for Nurses

Career exploration information website:

- **Critical-thinking skills.** Registered nurses must be able to assess changes in the health status of patients, including determining when to take corrective action and when to make referrals.
- **Communication skills.** Registered nurses must be able to communicate effectively with patients in order to understand their concerns and assess their health conditions. Nurses need to explain instructions, such as how to take medication, clearly. They must be able to work in teams with other health professionals and communicate the patients' needs.
- **Compassion.** Registered nurses should be caring and empathetic when caring for patients.
- **Detail oriented.** Registered nurses must be responsible and detail oriented because they must make sure that patients get the correct treatments and medicines at the right time.
- **Emotional stability.** Registered nurses need emotional resilience and the ability to manage their emotions to cope with human suffering, emergencies, and other stresses.
- **Organizational skills.** Nurses often work with multiple patients with various health needs. Organizational skills are critical to ensure that each patient is given appropriate care.
- **Physical stamina.** Nurses should be comfortable performing physical tasks, such as moving patients. They may be on their feet for most of their shift.

# SMC Nursing Program Criteria

- Admission to the Nursing program MUST meet the following criteria:
  - An overall grade point average of **2.5** for the Human Anatomy\*, Human Physiology\*, and Microbiology\* prerequisite courses, taken in the last 5 years, with no grade less than C for each course.
    - P/NP or CR/NC evaluative symbols are not acceptable.
    - **\*No on-line lab courses.** \*Exceptions have been made for core science courses completed (spring 2020 to summer 2022) at SMC or were pre-approved courses or schools pre-pandemic due to the COVID-19 campus closures/remote learning.
    - Starting fall 2022, the SMC Nursing program will resume requiring science prerequisite courses (Human Anatomy, Human Physiology, and Microbiology) be completed with an on-ground lab. Science prerequisite courses completed fall 2022 or later are required to have an on-ground lab.
    - Save/keep your course syllabus for science prerequisite courses, especially for courses completed spring 2020 or later.

# SMC Nursing Program Criteria Continued

- Admission to the Nursing program MUST meet the following criteria:
  - Only one repetition (excluding W) in the group of science prerequisite courses (Human Anatomy, Human Physiology, and Microbiology) is allowed within the last 5 years at the time of application.
  - College-level English composition class (minimum 3 semester units) with a grade no less than C\*
    - \*C- grade is NOT acceptable.
    - P/NP or CR/NC evaluative symbols are not acceptable.
    - AP English exam score of 3 or above will meet requirement. Official College Board Score Report required to be on file with SMC Admissions and Records Office.

# SMC Nursing Program Criteria continued

- Admission to the Nursing program MUST meet the following criteria:
  - Be in good standing at Santa Monica College (not on academic or lack-of-progress probation);
  - Meet the minimum physical qualifications (immunizations, physical exam) and essential functions (more information at [smc.edu/nursing](http://smc.edu/nursing));
  - Must have negative criminal background check and drug screening. Will be required to update regularly;
  - Persons who have been convicted of misdemeanor or felony may not qualify for licensure to practice nursing in California;
  - Must take and achieve the required score on an Admission Assessment (if invited, must take & achieve the required minimum score (160) on the approved Admissions Assessment (NLN NEX). The minimum required score determined by CCCCCO); and
  - Must have a valid Social Security Number or a valid Individual Tax Identification Number. Some clinical facilities may not accept ITIN.

# SMC Nursing Prerequisite Requirements (16 units)

Must be completed before applying AND grades must be posted on transcript  
(P/NP or CR/NC evaluative symbols are not acceptable)

**ENGL 1** – Reading & Composition 1 (3 semester units) or **ENGL 1D**, Reading and Writing Composition I- Diversity (3 semester units)

**ANATMY 1** – General Human Anatomy (4 semester units), prerequisite ENGL 1

**PHYS 3** – Human Physiology (4 semester units), prerequisites: ANATMY 1 & CHEM 19 (preferred) or CHEM 10

**MCRBIO 1** – Fundamentals of Microbiology (5 semester units), prerequisites: PHYS 3 & CHEM 19 (preferred) or CHEM 10

Suggestion: enroll in CHEM 19 (preferred) or CHEM 10 before ANATMY 1

Suggestion: CHEM 19 is preferred for PHYS 3 and MCRBIO 1, allied health majors, and many Nursing CSU transfer programs

# “Can I” vs “Should I” enroll in science prerequisite during winter/summer term?

- “In progress” Nursing program science prerequisites will not be accepted at the time of application.
- THINGS TO CONSIDER:
  - For any science prerequisite course in which a “C” or better was earned and repeated within the 5-year recency, the earliest course will be calculated for the purpose of GPA for admission evaluation.
  - Importance of course drop/withdrawal deadlines: a “W” will result in a deduction of points.
  - Consider the impact of “B” or “C” on CUM Science GPA points & overall Nursing Multi-criteria points.
  - Consider your ability to understand, retain, and ability to apply the information.

## Nursing Program and AS Graduation Requirements

### Additional Nursing Major Requirements

- PSYCH 19 - Lifespan Human Development
- COM ST 11 - Public Speaking (if completed summer 2013 or later) OR COM ST 35 - Interpersonal Communication

### AS Graduation (General Education) Requirements

***NOTE:** Students who have earned a baccalaureate or higher degree from a regionally accredited institution of higher education are not required to complete SMC local general education requirements. Coursework that is required to earn a nursing degree must be completed. (Per Educational Code 66055.8)*

- Humanities/Global Citizenship\* (Recommended: ENGL 2, but not a GC course)
- Social Science (SS Group A)/Global Citizenship\* (Recommended: HIST 10 or HIST 14, as these courses also satisfy the Global Citizenship requirement)
- Rationality (Math) (Recommended: MATH 54 generally CSU transfer path, review [www.assist.org](http://www.assist.org))
- \*Global Citizenship (GC) is a requirement for AS degree. Designated Humanities and SS Group A courses will satisfy a GE area and Global Citizenship requirement.
- Did you score a 3 or better on AP exams in high school? If so, request an official score report from the College Board be sent to SMC Admissions & Records Office.
- For additional Nursing Multi-criteria application points, focus on [SMC AS GE](#) and [SMC AA GEN SCI](#) major requirements.

# SMC Nursing Program Information: NURSNG 36 and NURSNG 17

- Ideal: complete NURSNG 36 & NURSNG 17 (offered fall & spring) before applying for additional points. Otherwise, enroll during gap semester. Example: apply summer 2024 for spring 2025 admission consideration > gap semester fall 2024.
- NURSNG 36 – Calculations in Drugs and Solutions (no prerequisite)
  - 1st 8-week section (reserved for incoming Nursing students initially and opens up at a later time for all students)
  - 2nd 8-week section
- NURSNG 17 – Pharmacological Aspects of Nursing (prerequisite PHYS 3)
- NURSNG 17 prerequisite waiver request is processed by the [Life Science Department](#) if human physiology course was completed at another college or university.

Attach transcript, course description/syllabus, include your name and SMC student ID number.

Initiate NURSNG 17 waiver request early as it can take weeks to process.

Health Sciences Counselors or front desk cannot expedite the process.

**Prerequisite Requirements:** Completion of Human Anatomy, Human Physiology, and Microbiology with a GPA of 2.5 or above (grade no less than a “C” in a course and no more than one repetition in any of these courses within the last 5 years at the time of application), and completion of college level transferable English, minimum of 3 semester units with a grade no less than a “C”.

# SMC Nursing Program Information: Application Process

- Review [SMC Nursing application](#) information/button
- Information and supporting documentation required at application, if applicable:
  - SMC student ID number (required)
  - Letter verifying employment/experience: licensed or certified healthcare worker\*/volunteer/other healthcare employment experience hours. Verification letter MUST include all required components on letterhead and total hours worked/volunteered.
  - \*Copy of valid healthcare License or Certification card/verification.
  - LVN to ADN advanced placements applicants are required to upload:
    - Employment verification letter that verifies LVN employment: one year's experience in direct patient care within the past two years at the time of application.
    - Copy of valid California LVN license at the time of application.
    - Have on file with SMC Admission and Records: LVN official transcript and all other college/university transcripts by **December 31 for winter/June 30 for summer application cycle.**
- Supporting documentation for Nursing Multi-criteria Life Experience area.

# SMC Nursing Program Information: Transcript & AP Score Information

- **IMPORTANT [TRANSCRIPT](#), AP SCORE REPORT, FOREIGN COURSEWORK (NON-SMC COURSEWORK) INFORMATION:**

- Non-SMC official transcripts/AP Score Report from **all** colleges/universities attended and attending are required to be on file with SMC Admissions and Records Office before applying: **December 31 for winter/June 30 for summer application cycle.**

Examples of transcripts/college coursework include:

- All US college/university transcript(s) you attended/attending or withdrew, including high school, certificate programs, etc.
- AP Score Report: if you scored a 3 or above on an AP exams. Recent exam score report: [AP score report](#) or for exams 4 years or older: [archived AP score report](#)
- LVN program/college transcript
- Military transcript
- Foreign college/university transcripts must be evaluated by a [SMC approved credential evaluation agency](#) and are required to be on file with SMC Admissions and Records Office before applying: **December 31 for winter/June 30 for summer.**
- Have you attended SMC or are currently attending SMC? If so, do not request an official SMC transcript be sent to SMC as the Nursing program has access to your SMC transcript.

# SMC Nursing Program Information: Admissions Assessment Test (NLN NEX: Passing score is 160)

- **Admission Assessment Test: Starting Fall 2024 the NLN will transition to the NLN NEX assessment.**
- After application season ends- eligible applicants receive invitation to test to their SMC email.
- If you pass, retaking the NLN NEX is NOT allowed for a better score.
- If you do not pass, you will receive letter regarding dates to schedule a counseling appointment to complete a Readiness Plan contract to be eligible to retest the following application cycle, at the earliest.
- Testing typically takes place twice a year: October & April.
  - Refer to the NLN NEX invitation letter for additional information.
  - Currently, SMC covers the cost of the exam through grant funding but subject to change and other fees may apply.
- Exam covers English/verbal, math & science: biology, anatomy & physiology, chemistry, & health.
- SMC does not cover the cost of study material- workbooks, apps, online test prep. Please study/review early.

- Four Semesters (2 years)- Fall & Spring
