- Sal reported that the two flex day sessions on Turn-It-In were well attended. Plans to pilot this as a small group of DE faculty is still a go for the April 15<sup>th</sup> term.

**Vice Chair's Report:**

- Julie reported that the flex day eCompanion session was well attended with over 60 faculty participating.
- After a four-year absence of no campus-wide eCompanion trainings, there have been five sessions since last May. An additional session has been scheduled for May. Faculty interest in using eCompanion is high.

**Ongoing Projects:**

- Sal handed out copies of the Palomar Community College's recent version of their faculty readiness document submitted by Wendy Parise. The topic of faculty readiness to be discussed at the next meeting.
- Sal updated the committee on the ISC AR's. The committee will need to review the DE AR's and submit changes including any deletions and additions.

**Committee Members Discussion/Reports:**

- The majority of the meeting was devoted to discussion and suggestions for creating and deploying a Distance Education student user satisfaction survey.
- It was agreed that due to the time involved in the survey creation, the survey would be deployed to Distance Education students in fall 2013.
- Sal & Julie will work with Ani on distilling the questions then forward to the committee for consideration and further discussion.
- Julie will email the committee a copy of the draft of the student survey created by the Chancellor's office as a reference/guide.
