Approval of Minutes: A motion to approve the minutes of 10/9 was made by Dana Del George seconded by Wendy Parise and unanimously approved.

Chair's Report:

- The 11/6 DE meeting has been cancelled due to scheduling conflicts.
- Add Code discussion was presented to the Academic Senate. The concerns about the current system/process and its effectiveness go beyond the distance education community and will now include all stakeholders. DE committee members suggested ability to purge waitlisters, create add codes earlier (two weeks out), creating an expiration date on add codes, having the ability to text students as a communication tool tied to add codes (and beyond). When will a texting option be made available in mProfessor?

Announcements

- Christine Miller announced upcoming eCollege exam enhancements being released to our campus including randomizing distracters. These will be available in the exam toolbox.

Vice Chair's Report:

- OEI Update: Course rubric guidelines have been posted to FAC 101 document sharing. Michelle Pillati, former President of Statewide Academic Senate now chair of the Professional Development committee, has been one of the leads in the formation of these guidelines along with other CCC OEI faculty in this workgroup.
- OEI Common CMS: RFP went out 9/8. Responses due 10/20 and contact expected to be signed 12/31. It remains to be seen if non-OEI institutions will be able to benefit from the CMC and other related services such as tutoring and proctoring.
