STUDENT & ATHLETE INJURY PROCEDURES

On Campus Injury:

- 1. Send student/athlete to Health Office for initial treatment and physician referral.
- 2. Health Office and student will complete and retain a copy of the Anthem Blue Cross Claim form, HIPAA form and Billing Instructions. Student shall provide the medical facility with a copy of the claim form and billing instructions. Immediately forward all forms to Risk Management for processing with Student Insurance Agency.
- 3. <u>Work-Experience/Occupational Training</u> Students who are enrolled in a course which is considered work-experience education or occupational training (i.e., nursing students; cosmetology students) is considered to be an employee of the District and shall complete and return Workers' Compensation Claim Forms to Risk Management (See Ed. Code §78249; CA. Labor Code §3368).
- 4. <u>Student Workers</u> are considered employees of the District and shall complete and return Workers' Compensation Claim Forms to Risk Management.

Athletic Injury:

- 1. During sports season, student should report injury to Athletic Trainer for treatment and physician referral. During off-season, student should report to Health Services.
- Trainer and student will complete and retain a copy of the Anthem Blue Cross Claim form, HIPAA
 form, and Billing Instructions. <u>Immediately</u> forward all forms to Risk Management for processing
 with Student Insurance Agency.

Field Trip Injury:

- 1. District employee supervising field trip will contact emergency response personnel.
- 2. District employee and/or student will report injury to Health Office upon return to campus. Health Office and student will complete claim forms and forward copies to Risk Management.

**STUDENTS COMPLETING STUDENT INJURY CLAIM FORMS SHOULD REFER TO BILLING INSTRUCTIONS IF THEY RECEIVE A BILL FROM MEDICAL PROVIDER.
