## Discussion Item: Revising the Curriculum approval process for DE

Chair Morris presented a discussion draft of a proposal to update and revise the form used by the Curriculum Committee to approve courses for online delivery. Both the current and incoming Chairs of Curriculum were invited and able to participate in the discussion. The current Curriculum approval form consists of eight sets of prompts, each accompanied by guidelines for promoting best practice in online course design and pedagogy. To focus and streamline that form, eliminating redundancy and updating now-obsolete information (e.g., references to eCollege and FAC 101), this discussion draft proposes shortening the form to just four sets of prompts and updating and consolidating the best-practice guidelines in a separate format. The overall goal is to facilitate a process that allows the Curriculum Committee to fulfill its responsibility for approving courses for online delivery, as directed by Title 5 and guided by the Chancellor's Office, while also allowing the DE Committee to continuously update and promote best practices.

This discussion will need to continue in the Fall, when the DE and Curriculum committees reassemble.
