#### IV. Action & Discussion Items

- a. <u>Synchronous Teaching: Camera Use Resolution DRAFT</u> Discussion with Equity and PD Committee Members
  - 1. K. Chicas met with the committee to share suggestions and concerns regarding the draft of the resolution on behalf of the Diversity and Equity Committee. There were concerns that the resolution was not detailed enough to provide faculty and students with policies and protocols surrounding alternative options should a student opt out of using a camera. There was also discussion regarding Proctorio use, in which T. Whitaker clarified that the resolution is only addressing camera use in synchronous online courses at the moment.
    - E. Meyer suggested the document provide additional clarification and framing to avoid confusion about the intention of the resolution. She also would like the language to specifically address Black and Latinx students in the statement surrounding student groups. There was robust discussion among the committee regarding using terminology such as "underrepresented" vs. "minoritized" vs. "underserved" to describe student groups.
  - 2. Committee members and guests shared additional possible reasons a student may not feel comfortable turning on a camera (i.e. privacy concerns, uncomfortable around a faculty member, etc.)
