IV. SUPERINTENDENT'S REPORT

Management Association Update: Erica LeBlanc, President-Elect of the Management Association, announced that Kiersten Elliott, Associate Dean of Enrollment Services and President of the Management Association, is the winner of the September "Above and Beyond" award, presented to exceptional managers.

State Budget: There has been no recent change to the state budget as it applies to community colleges, but SMC could be affected in some way by the current economic difficulties experienced at both the national and state levels. There is hope, however, that the college's budget can be maintained at its current capacity this year and that SMC will weather the economic storm in the longer run.

Bond Measure: Director of Government Relations and Institutional Communications Don Girard reported that the Yes on Measure AA campaign, which is working on behalf of the \$295 million SMC bond measure on the November 4th ballot, has been busy on several fronts: absentee ballots have been mailed; the list of endorsements has grown and includes all college organizations as well as many outside SMC; a successful campaign kickoff event was held October 6th; and the Associated Students has committed a total of \$50,000 for the campaign.

Music Department Events: Music Department Chair Rhoda Tuit reported that the program will soon be inaugurating a concert series in the newly opened Broad Stage at the SMC Performing Arts Center. Six concerts are scheduled in the 499-seat venue for the fall semester, with a Music Department Opening Concert scheduled for October 25th. Several more concerts are scheduled in the adjoining Edye Second Space, a 99-seat "black box" at the Performing Arts Center that opened in fall 2007.

China Education Exchange/Theater Arts Production for Shandong University: Communications Professor Nancy Grass Hemmert and Theatre Arts Department Chair Perviz Sawoski reported that SMC is about to embark on an historic cultural exchange trip with Shandong University of the Arts in Jinan, China. A group of 18 theatre arts students, along with two student journalists, leave Saturday for a pioneering 8-day trip to stage "American Reflections: Broadway in Concert," a revue of numbers from Broadway shows of the past 80 years, at Shandong as part of the university's 50th anniversary.

SUBJECT: ACCOUNTABILITY REPORTING FOR COMMUNITY COLLEGES

- <u>SUBMITTED BY</u>: Superintendent/President
- <u>SUMMARY</u>: Executive Vice-President Randal Lawson and Caroline Sheldon, Dean of Institutional Research, will present an overview of the Accounting Reporting for Community Colleges (ARCC).

Accountability Reporting in the Community Colleges (ARCC) contains seven measures of student progress and achievement as they relate to the broad mission of the California Community Colleges to support transfer, degree and certificate completion, and basic skills. The measures developed for ARCC reflect a refinement of some of the measures from previous accountability initiatives, such as the Partnership for Excellence (PFE), as well as an expansive consultation process with education scholars and community college practitioners from the field.

The legislation for Accountability Reporting in the Community Colleges (ARCC) requires that a college's local Board of Trustees annually review the college's ARCC report. No action is required by the Board; review of the narrative, and the selection of material contained in Appendix A, fulfills this legislative requirement.

SUBMITTED BY: Trustees Nancy Greenstein and Louise Jaffe

<u>ACTION:</u> It is recommended that the Board of Trustees support Measure R on the November 4, 2008 ballot.

<u>SUMMARY:</u> In July 2008, the Metro Board of Directors authorized placing a half-cent sales tax before voters to fund transportation projects within Los Angeles County. Measure R is expected to provide the local resources to finance new transportation projects and accelerate those already in process. Over 30 years, it is projected to generate \$40 billion for congestion relief projects. Measure R alone does not fully fund all projects. The expenditure plan identifies additional funding sources. It is estimated to cost residents an average of \$25 per person each year.

Authorization of contract award to JEM Resources Partners, a 403(b) Third Party Administrator, to provide 403(b) Plan Administration services to the District for one year, with four one-year options, at \$2.00 per participant per month in year one of the contract.

Funding Source: 2008-2009 District Budget

Comment: A 403(b) plan is a retirement plan for which a specific group of public schools are eligible and where the District may determine the financial institution(s) that the eligible employees can maintain their 403(b) accounts. Currently, there are approximately 400 employees who participate in 403(b) accounts.

Effective January 1, 2009, mandated changes in IRS Code 403(b) regulations will shift a larger portion of the compliance administration from 403(b) vendors to employers.

Current compliance issues evolve around tracking contribution limits and loan rules, approving distributions and providing reports. JEM will assure that the District's plan is maintained in compliance with the laws of California.
