## Sidley Pre-Law Scholars Initiative

Accepted students will be immersed in a rigorous eight-week program where they will be able to receive the necessary skills to prepare them for their journey toward law school. These students will participate in five weeks of instruction including introductory law school classes, legal writing, and trial advocacy, taught by law school faculty, and three weeks of legal internships.

**Eligibility:** Students should be first-generation college students, low income, or members of groups underrepresented in the legal profession. Students must hold a cumulative grade point average of 3.0 or better and must be in their first two years of college. Students attending community college must show proof of college continuance by providing a copy of the acceptance letter from the 4-year institution they will be attending in the Fall. Preference will be given to students who have joined DiscoverLaw.org.

## UHLC Pre-Law Pipeline Program (Scholar II), University of Houston-Law Center
