B. Review of 7120.1

The PPC Chair and Vice Chair presented to the Chair of Chairs February meeting on the possible removal of the two required recommendation letters for full time faculty within AR 7120.1. A poll was conducted after the presentation to gauge the interest of department chairs in moving forward with this proposed change. Poll results showed that the majority of chairs support the removal of the two required recommendation letters as a part of applicant submission. Department Chairs also expressed interest in updating the Reference Form used during the final round interview selection.

The committee will work towards finalizing proposed changes at the next committee meeting to then vote on and take to Academic Senate Executive Committee and the full Senate.
