3. Old Business
  - a. AR 4332 Progress Renewal, AR 4111.6 Transfer Credit, and AR 4114 Student Success and Support are on the way to Senate Exec.
  - b. AR 4420 Enrollment and Scholarship Standards for Participation in SMC Student Government is on hold until Deyna is back in the office to participate in the subcommittee to review this AR. The Committee is also waiting to hear from the students regarding the proposed amendments they will be making to their constitution.
  - c. AR 4342 Standards of Student Success - Probation and Disqualification
    - i. Hannah Lawler presented data on a cohort of students to see whether student’s performance or completion was affected when the tiered percentage completion rate was changed.
      - a. The data presented was not conclusive enough to support status quo or to make a change in reducing the course completion rate from 60% to 50%.
      - b. Laurie is going to share the research with the Counseling Department and bring the feedback back to SAC.
4. New Business
  - a. AR 4110 Residence Regulations
    - i. Esau revised this AR to reflect legislative recent changes in residence classification standards.
    - ii. Motion to approve the revised AR by Lucy Kluckhohn-Jones, 2nd by Denise Kinsella. The Committee voted 8 yes - 0 no - 0 abstain, to approve the revised AR with a few amendments made for clarification purposes.
