I. Call to Order 11:17 a.m. and Approval of Agenda

L. Kawaguchi asked to remove Item E. (motion to approve Measure V) from the agenda and to remove Item IV B. Motion on the Global Council from the consent agenda.

Item III E was removed from the agenda because, according to Ed. Code Section 7054, "No school district or community college district funds, services, supplies, or equipment shall be used for the purpose of urging the support or defeat of any ballot measure or candidate, including, but not limited to, any candidate for election to the governing board of the district." F. Chandler indicated that College Counsel concurred with this move.

A. Canvas Migration Report, P. Morris. DE Chair

This is last semester eCollege will be used. In winter Canvas will take over. All but 18 online instructors have migrated to Canvas.

Training is available. @One also offers same training. Training is self-paced and takes about two weeks to complete. Individual mentoring is available too. 350 faculty use eCompanion. 180 use eCollege. The rest do not have an online presence. Canvas might be the solution for these faculty; it has many useful features; e.g. it can take attendance in real time. In Nov. the mentoring team will offer individual office hours for faculty who take the training.

The team is also available for department level training this semester.

All faculty can log into Canvas now. It was recommended that faculty add Canvas Central to their dashboards. The team also suggested using "Vote" for adding features. Canvas apps are available for students using mobile device for their classes.

Release time and stipends are ending for mentors. Priority of service will be for online teachers.

Motion from Exec: The Academic Senate acknowledges the importance of the work of the joint Distance Education Committee in reviewing standards that will result in a refinement of the common understanding of what constitutes regular and effective contact for distance education courses. Furthermore, the Academic Senate looks forward to approving those standards as part of its Title V responsibilities to oversee the development of standards and policies regarding student preparation and success.

The committee's best practices, refinement of the meaning of regular and effective contact, etc., will come to the Senate for approval before they are released or disseminated. Revisions to the Curriculum form and the AR for distance education will also be presented.

Comment related to Objective 2 g: The entire \$45,000 of PDC money has already been encumbered. However, there is still a definite need for faculty to participate in discipline-related professional development activities. We will check into how other colleges handle professional development funds. SMC stopped giving the PDC money when the governor started contributing.

C. [Open Educational Resources \(OER\) Progress Report, J. Darwiche](#)

J. Darwiche reported on a Cengage survey that indicated that 4% of higher ed. courses use open educational resources (OER). The effort is growing nationwide and will triple in next 5 years.

Last June SMC applied for funds from the state (AB788) targeted for community colleges and CSU. \$50,000 is the maximum awarded per campus, and we will very likely receive the funds requested because of the number of sections committed to converting to OERs.

Jinan thanked the faculty, staff, administrators who have helped with this effort. She asked senators to send suggestions and ideas to her and to check Cool4Ed.org to review resources for their classes.

in-progress applications for spring. 149 students have indicated a degree in interaction design is their goal.

- 4% of the higher education respondents use OER as primary materials.
- The subjects of mathematics (13%) and computing (11%) had the highest usage.
- English (2%) and psychology (1%) had the lowest, according to the survey.

For supplemental materials, OER is used by:

- 5% of the respondents overall:

- 18% in computing, 13% in mathematics,
- 8% in English and
- 4% in psychology.
