- 1. Update from committee members
 - a. Ad hoc committee motion: Chris Bonvenuto

Don Girard, Senior Director, Government Relations/Institutional Communications will lead the ad hoc legislative committee. Therefore, a lucrative contract is needed to pursue running this department. Currently, this is not actively being pursued.
