IV. Reports/Discussion

 Chris Bonvenuto gave a summary of Governor Newsom's 2024-2025 Budget Proposal. This is the beginning of the State budget process, things can and will change. <u>Governor's Proposed Budget Summary</u> Projected <\$37.9 billion> budget deficit, LAO projects <\$68.0 billion> budget deficit Governor notes risk but does not forecast a recession

Governor's Proposed Budget Solutions

Use \$13.1 billion in reserves, \$8.5 billion in reductions=Reduction of \$495 m in Student Housing Loan Funds and reduction of \$350 m in Legislative requests. No funding delays nor deferrals for community colleges. Governor's proposed budget solutions reduce the State Reserves from \$37.8 b to \$18.4 b

<u>Proposed Ongoing Changes for Community Colleges</u> Inflationary Adjustment (COLA) of 0.76% ~\$1.27 m for SMC

Proposed One-time Changes for Community Colleges \$60 m expanding nursing program capacity

Comparing 2023-2024 Enacted to 2024-2025 Proposed

- 2023-2024 Enacted Budget Act Total Change: \$308 million
- 2024-2025 Governor's Proposal Total Change: <\$3.6> million
