1. 2nd Quarter Budget Update

Governor's Proposed Budget Summary

Projected <\$37.9 billion> budget deficit, LAO projects <\$68.0 billion> budget deficit Governor notes risk but does not forecast a recession

FTES and Other Major Items of Note

FTES projections: Credit Resident FTES 3.375% or 542.51

Since 2020-2021 Credit Resident FTES is <2,484> or <13.01%> lower

Non-resident FTES: 11.39% or 323.94 FTES, Decline of <1,421> or <30.9%> since 2017-18

Budget Savings Measures - Update

Tentative Budget: identified 2024-2025 negative fund balance with no action and

\$20,000,000 in savings needed to meet 5% fund balance

Adopted Budget: identified ~\$8.5 million in 23-24 savings, carried into 24-25=~\$17 million savings

Used \$3.8 million one-time HEERF

Increase Efficiency in the Schedule: Budgeted for 92.3% WTH to Resident FTES ration

2020-2021: 19,920 Resident FTES with 22,068 WTH = 90% Efficiency 2022-2023: 16,910 Resident FTES with 21,504 WTH = 79% Efficiency

Efficiency Goals Not Met

Adopted Budget: 17,393 Resident FTES with 18,842 WTH = 92.3% Efficiency 2nd Quarter Budget: 17,487 Resident FTES with 20,786 WTH = 84.1% Efficiency

Issues Moving Forward

Large State Budget Deficit, 0.76% Inflationary Adjustment (COLA) Proposal, Hold Harmless Provision Not Proposed to Change (no COLA increases starting 2025-2026) The District Must Implement Additional Savings Actions
