- a. Continued discussion to improve the long-term Fiscal Stability of the District.
  - Revenue Generation and other ideas
    - 1) Review the contract with Xerox for savings Mitch Heskel reported the contract is coming to an end, and as part of a new RFP, Educational Enterprise/Reprographics will perform an analysis on departmental usage and develop a plan to reduce the number of devices if appropriate.
    - 2) Corporate Sponsor for beverages/food-related marketing rights Mitch Heskel will investigate the possibility of a sponsorship and report back to the committee.
    - 3) Implement Credit for Prior Learning Teresita Rodriguez is working with CCIS and will report back on Career Choice-stackable degrees/certificates. Elisa Meyer will follow up with Sal Veas for an update from the Business Department.
    - 4) Contract Education This may be an area the college can tap into new markets and create partnerships with local technology and other companies to train their employees for a fee. Chris Bonvenuto will reach out to Contract Education for input.
    - 5) The Budget Committee approved the following recommendation:

To immediately form and ad hoc committee consisting of leaders of all constituency groups to address inadequacies of the Student-Centered Funding Formula (SCFF) through legislative action and in collaboration with other districts and groups.
