
The Santa Monica Community College District (SMCCD), as Lead Agency under the California Environmental Quality Act (CEQA), is providing this courtesy notice that it has completed a Final Environmental Impact Report (EIR) for the Santa Monica College Facilities Master Plan 2010 Update ("Proposed Project").

As required by CEQA, the Draft EIR for the Proposed Project was prepared and circulated during a 45-day public review period that began on April 21, 2010 and ended on June 4, 2010. Following the closure of the public review period, the College began the preparation of the Final EIR for the Proposed Project, which is the subject of this notice. Pursuant to Section 15132 of the State CEQA Guidelines, the Final EIR includes a list of persons, organizations, and public agencies that commented on the Draft EIR; all comments and recommendations received on the Draft EIR; written responses to each comment provided on the Draft EIR; and corrections and additions, as appropriate, to the Draft EIR.

Copies of the Final EIR, as well as the Draft EIR, Draft EIR Technical Appendices, and the Santa Monica College Facilities Master Plan (2010 Update), are available for the public to view via the College's official website at www.smc.edu/facilities_masterplan and at SMC's Administrative Offices during normal business hours at 2714 Pico Boulevard, Room 320, Santa Monica, California 90405.
