6.1 Discuss and approve changes to the Election Code.

- Section 3, part A number 3, will be revised to: In the event that a candidate decides to run for an alternative position, new candidates petition must be filled and submitted by March 12th (Tuesday), at 5pm and no further extensions will be provided.
- Section 4, part B changes:
 1. No candidate or his/her representatives shall incur expenses in excess of two hundred and fifty dollars (\$250.00) over the official campaign period and the run-off election (if necessary). Any slate may spend up to \$250 on their campaign, with an additional \$15 per slate member for a maximum of up to \$335 for a slate of eight people. **(2 sentences were moved to number 4 from this number.)**

2. Each candidate expressing financial need (must provide proof and documentation of financial need) will be reimbursed up to **\$150**. Funds will be dispersed based on financial need and on a first-come first serve basis.
 3. Cash advances will be available up to **\$50** at the start of campaigning on a first-come first-serve basis for those expressing financial need and can provide documentation to the office of student life.
 4. The expense account and statement must be submitted to the Associated Dean of Student Life, or the designee, by 1 pm on the third Friday (April 5th), beginning the week after elections, subject to change in the event of a run-off election (by Monday 5th, 5pm). **A completed expense account and statement (contained in this election packet), including \$0 (zero) expenditures, must be submitted for both regular and run-off elections. Slates must submit a combined expense account statement in lieu of individual statements. Original receipts must be submitted with this document.** This is a sworn statement from the candidate attesting to the accuracy of the candidate's expenses.
 5. No changes have been discussed yet.
 6. No more that **60 percent** of any candidates or slates budget or product donations can be spent on paper products. Paper products include flyers, posters, business cards, 4-ups etc.
- Section 4, part C number 15 gets removed.
 - Section 4, part D: Adding "candidates may not post more than 5 promotional posts in the SMC unofficial Facebook page."
 - Section 4, part F: Correct the indentation problem on top of the page 11.
 - Counselor Gordan, had to leave the meeting at 5pm.
