  - Nader- Nader is torn on this topic. The political side to this is we should do the job verses the fact that we are students and some forego paid jobs in order to do their job and sit on committees and have the same financial needs as other students on campus.
  - Kevin- Kevin would not feel accepting the same amount of stipends because he does not do as much work as other directors
  - Final outcome: There will be no stipend offered to Directors for sitting on committees because the purpose of this is to get new students involved in Associated Students.
