- 9.1 Determination of the meaning of voting rights and the effects on holding a position of leadership within the Associated Students
  - Tiffany: any student has a right to talk about it, but should not be able to vote due to conflict of interest.
  - Cameron: In our Fiscal Policy we have a conflict of interest of financial or personal interest
  - Chris: It is the practice that a director cannot hold the position of President of a club or ICC Rep.
  - Cameron: can be the Vice President, Secretary or Treasurer. We need to make it clear
  - Michael: outside organizations and Clubs are different
  - Dean Hearn: There needs to be language for who can vote in regards to Club members and CALPIRG members. If you are member of a an outside organization, you can vote, but not if you are an officer of the organization then you can not vote.
  - Kevin: felt uncomfortable at times with pressure from both sides.
  - Natasha: agrees with Michael that outside organizations and Clubs are different.
  - Jo Kidd: you operate under Roberts Rule of Order and Lee Peterson has something you should hear.
  - Lee Peterson: Financial conflict of interest, mutually incompatible offices, section 45 voting procedure abstaining of voting on question of personal interest, of effecting one's self. P 394 of paperback version of Robert's Rules of Order
