(SMC Administrative Regulation, Section 4000)

- Club minutes must reflect the election of the officers; see backside #V NEW BUSINESS.
- At least one club officer and the club advisor must review and sign the club minutes.
- The new President and new Liaison will need to complete the ICC Orientation & Quiz within 2 weeks from the date of submitting this Roster Form.
